NOTICE OF MEETING OF BOARD OF DETERMINATION

Notice Is Hereby Given to you as an affected property owner or governmental unit potentially liable for an assessment, that a Board of Determination, composed of **Jim Pearson, Trish Roberts, Toni Thompson, and alternate Jeff Sorensen**, will meet on **Monday, October 21, 2013 between 7:00 p.m. to 9:00 p.m. at Oshtemo Charter Township Hall, 7275 West Main, Kalamazoo, MI 49009**, to hear all interested persons and evidence and to determine whether the drain known as the LaSalle Homesites Plat County Drain (Drain No. 132), as prayed for in the August 16, 2013 Petition for the cleaning out, relocating, widening, deepening, straightening, tiling, extending or relocating along a highway of the drain known and designated as the LaSalle Homesites Plat County Drain (Drain No. 132), located and established in the Charter Township of Oshtemo, in the County of Kalamazoo and the State of Michigan, is necessary and conducive to the public health, convenience or welfare of the Charter Township of Oshtemo, in accordance with Sections 72 and 191 of Act No. 40, P.A. 1956, as amended, and whether said drain is necessary for the protection of the public health of the Charter Township of Oshtemo. And, further, to determine whether it is necessary to add lands to the Drainage District pursuant to Section 197 of Act No. 40, P.A. 1956, as amended. A map depicting the properties located in the LaSalle Homesites Plat County Drain Drainage District is available for inspection at the office of the Kalamazoo County Drain Commissioner.

Proceedings conducted at this public hearing will be subject to the provision of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the Kalamazoo County Drain Commissioner at 269-384-8117.

You Are Further Notified, that persons aggrieved by the decisions of the Board of Determination may seek judicial review in the Circuit Court for the County of Kalamazoo within 10 (ten) days of the determination.
