NOTICE OF MEETING OF BOARD OF DETERMINATION


Notice Is Hereby Given to you as an affected property owner or governmental unit potentially liable for an assessment, that a Board of Determination, composed of **Ann Nieuwenhuis, Jack Gesmundo, Randy Smith, and alternates Kim Steinmann and Jeff Sorensen**, will meet on **Wednesday July 10, 2013 between 7:00 p.m. to 9:00 p.m. at Portage City Hall, 7900 South Westnedge Avenue, Portage, Michigan, 49002**, to hear all interested persons and evidence and to determine whether the drain known as the Lexington Green County Drain (Drain No. 319) as prayed for in the February 26, 2013 Petition for the investigation and repair, alteration and modification, including cleaning, reconstruction, extension or other improvements of the drain designated as the Lexington Green County Drain (Drain No. 319) located and established in the City of Portage and the Township of Pavilion, in the County of Kalamazoo and the State of Michigan, is necessary and conducive to the public health, convenience or welfare of the City of Portage and Township of Pavilion, in accordance with Sections 72 and 191 of Act No. 40, P.A. 1956, as amended, and whether said drain is necessary for the protection of the public health of the City of Portage and the Township of Pavilion. And, further, to determine whether it is necessary to add lands to the Drainage District pursuant to Section 197 of Act No. 40, P.A. 1956, as amended. A Lexington Green Drainage District map is on the back side of this notice.

Proceedings conducted at this public hearing will be subject to the provision of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the Kalamazoo County Drain Commissioner at 269-384-8117.


