Vice Chairman Buskirk convened the Committee of the Whole at 4:00 p.m.

#### 1. <u>Review of Transfers and Disbursements</u>

Ms. Tracie Moored, Finance Director stated claims for November 5, 2014 totaled \$1,980,948.13. She indicated there was a release of fund to the Kalamazoo County Public Housing Commission in the amount of \$150,000.

She also indicated there were two budget line item transfers.

#### 2. Brownfield Plan for Site in Oshtemo Township

Ms. Lotta Jarnefelt, Planning & Community Development Director reviewed her memo as included in the packet. She indicated Board approval would occur at the November 18<sup>th</sup> Board meeting.

Mr. Joe Agostinelli, Chair, Brownfield Redevelopment Authority Board reviewed the project plan as distributed.

Chairman Maturen arrived at 4:05 p.m.

Commissioner Rogers stated she supported this project. She stated she felt this was a win-win project.

Vice Chairman Buskirk stated he too supported this plan and felt it was a good way to utilize funds down the road.
