***NEW* CERVICAL CANCER TESTING
PILOT PROJECT**

The SW Michigan BCCCNP is now able to enroll women age 21 – 39 for a screening Pap test. Women must meet current eligibility guidelines; income 250% of poverty level, inadequate or no insurance.

The Centers for Disease Control (CDC) is now looking at percentages of women who have **NEVER** had a Pap test. We are hoping to capture some of those women in this Pilot Project. Priority enrollment should be given to those women never screened.

Women age 21-29 are eligible for a screening Pap test only, every 3 years (HPV testing is unacceptable for screening women in this age group).

Women age 30-39 are eligible for a screening Pap test every 3 years, OR, HPV test only every 5 years, OR co-test Pap & HPV every 5 years.

UPDATED BCCCNP FORMS AND WHERE TO FIND THEM

(Consent) Agreement Forms:

As of October 1, 2018, we rolled out an updated (Consent) Agreement form with a new title. It is now called the ***Agreement for client participation and permission to obtain results*** forms (2 pages). Everyone should be using these forms as it is mandatory per the State legal department. All old consent form copies should be thrown out.



Don't Forget: New Agreement form needs to be signed by office staff in addition to client signature.

Payable Screening Dates Form:

Every new fiscal year we update this form to reflect current BCCCNP information. Many of our sites use this form to verify that a client is due for services. We can provide the client's history with the BCCCN Program if sent prior to the office visit or service needed.

BCCCNP CASELOAD INCREASED!

Our SW MI Breast and Cervical Navigation Program has received an increase in available caseload for fiscal year 2019. This means that for FY19 (until 9/30/2019) we have 640 slots available to accommodate additional women who may seek services.

All clinics should have received their caseload numbers for FY19 via email in September 2018. If you have questions regarding your caseload, please call Tammy @ 269-373-5383.

The 75/25 restriction regarding screening mammograms remains in place for FY19.

BCCCNP WRAP-AROUND GRANT

Ninety-two clients have received assistance paying for breast testing/services through our current Wrap-Around Grant funded by Susan G. Komen Michigan.

Priority enrollments are for women under age 40 who need a screening mammogram, those who cannot get a slot into BCCCNP and Men.

Please note: BCCCNP can only pay for approved codes. We continue to see the ICD-10 code Z00.00 which is a general adult physical exam and not specific to breast/cervical testing. To ensure payment for an office visit, please refer to the current approved codes on the BCCCNP website.

SCREENING MAMMOGRAMS

Clients come to the BCCCN Program through many different avenues; Enrollment sites, Radiology sites, Referral sites, to name a few. No longer do we require an initial clinical breast exam in order for a woman to receive a screening mammogram. For example, your client may be sick and has scheduled an office visit. She may also be due for her mammogram. If you know she meets eligibility for BCCCNP have her complete the enrollment paperwork and then schedule the screening mammogram. Be sure to send us the paperwork along with the date of her

scheduled mammogram, so that we know she is enrolled. Remember, in this case we will be funding the mammogram only, not the office visit. Of course, if your client is due for her Pap test as well as a mammogram then a breast/cervical office visit on another day would be appropriate.
