Senior Millage Renewal														
For the purpose of continuing a local fund as previously approved by the voters in 2018 to provide education, safety, dignity, independence, home services, and healthy living programs to Kalamazoo County residents age 60 and older (Seniors) using the Kalamazoo County Health & Community Services Department to improve the quality of living for our Seniors, shall the limitations on the total amount of taxes which may be levied against taxable property within Kalamazoo County, Michigan, as provided for by Section 6 of Article IX of the Michigan Constitution of 1963, be renewed at the level previously authorized as reduced by the Headlee Amendment at the rate of up to \$0.3462 per thousand dollars of taxable valuation (0.3462 mills), for a period of six years, beginning with the December 1, 2024 levy and extending through the 2029 levy, which shall raise in the first year an estimated \$ 3,696,436. For example, on a property with a residential market value of \$200,000 (with an estimated taxable value of \$100,000), the 0.3462 mills would equal approximately \$34.62 of levied tax annually to support Older Adults throughout Kalamazoo County.

Shall the expired previously voted increase in the tax limitation imposed under Article IX, Sec 6 of the Michigan Constitution in Climax Township of 1.5 mills (\$1.50 per \$1,000 of taxable value), 2014 through 2023 inclusive, and reduced by required millage rollback, be renewed at and increased up to the original voted 1.5 mills (\$1.50 per \$1,000 of taxable value) to be levied for a period of ten (10) years, 2024-2033 inclusive, for dedicated funding of the Climax Township Fire Department, raising an estimated \$135,655.39 in the first year of such levy?

Shall the previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Ross Township, Kalamazoo County, Michigan of up to 1 mill (\$1.00 per \$1,000 of taxable value) presently reduced by the required millage roll backs and which millage will expire with the 2024 tax levy, be renewed at 1 mill (\$1.00 per \$1,000 of taxable value) and levied for five (5) years, 2025 through 2029 inclusive, on all taxable real and personal property in the Township, including the portion of the Village of Augusta within Ross Township, for disbursement to Ross Township for the purpose of operating and maintaining fire protection services and related emergency services provided by the Augusta-Ross Township Fire Department, including the purchase of vehicles, apparatus, equipment, and housing, thereby raising an estimated \$468,757 in the first year the millage is levied.

Special Education Millage Renewal Proposal														

This proposal will permit the intermediate school district to continue to levy special education millage previously approved by the electors.

Shall the currently authorized millage rate limitation of 0.8955 mill (\$0.8955 on each \$1,000 of taxable valuation) on the amount of taxes which may be assessed against all property in Van Buren Intermediate School District, Michigan, to provide funds for the education of students with a disability, be renewed for a period of 5 years, 2025 to 2029, inclusive; the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2025 is approximately \$4,506,437 from local property taxes authorized herein (this is a renewal of millage that will expire with the 2024 tax levy)?

Local School District

Portage Public Schools

Proposal to Renew Building and Site Sinking Fund

This proposal will renew the authority last approved by the electors in 2019 and which expires with the 2024 levy for the School District to levy a building and site sinking fund millage, the proceeds of which will be used to make improvements and repairs to the School District's facilities. Pursuant to State law, the expenditure of the building and site sinking fund millage proceeds must be audited, and the proceeds cannot be used for teacher, administrator or employee salaries, maintenance or other operating expenses.

Shall the Portage Public Schools, County of Kalamazoo, Michigan, be authorized to continue to levy 0.4988 mills (\$0.4988 per \$1,000 of taxable valuation) for a period of five (5) years, being the years 2025 to 2029, inclusive, to maintain a sinking fund to be used for the construction or repair of school buildings, school security improvements, the acquisition or upgrading of technology, the acquisition of student transportation vehicles, trucks and vans and parts, supplies and equipment used for the maintenance of these vehicles and for any other purposes permitted by law? This millage if approved and levied would provide estimated revenues to the School District of approximately \$1,596,118 in the first year that it is levied.

District Library

Charles A. Ransom District Library

Library Millage Renewal Proposal

Shall the Charles A. Ransom District Library, Counties of Allegan and Kalamazoo, be authorized to levy annually a renewal of the previously authorized millage, which expires in 2024, in an amount not to exceed .58 mill (\$0.58 per each \$1,000 of taxable value) against all taxable property within the Charles A. Ransom District Library district in perpetuity beginning with the 2025 levy, for the purpose of providing funds for all district library purposes authorized by law? The estimate of the revenue the District Library will collect in the first year of levy (2025) if the millage is approved and levied by the District Library is approximately \$350,000.

By law, a portion of the revenue from the millage may be subject to capture by the City of Plainwell's Brownfield Redevelopment Authority.
