Fees for residential County customers without a municipal contract

Kalamazoo County Residential Customers.....\$8.00**

Kalamazoo County Small Business Customers will be billed at \$18.00 per ¼ hour plus disposal costs.

Fixed For Profit and Schools.....\$530.00 + 30.00= \$560.00

Non Profit Fixed.....\$530.00 + 5.00 = \$535.00

Seasonal\$155.00 + 30.00 = \$185.00

Non-Profit Seasonal.....\$155.00 + 5.00 = \$160.00

Temporary\$150.00 + 9.00 = \$159.00

Non-Profit Temporary.....\$150.00 + 5.00 = \$155.00

Mobile Food Service License\$250.00 + 30.00 = \$280.00

Special Transitory Food Unit.....\$200.00 + 44.00 = \$244.00

Non-Profit Special Transitory Food Unit.....\$200.00 + 5.00 = \$205.00
