**Kalamazoo County Park Splash Pad Rules & Regulations –Adopted 10/6/2009**

### **KALAMAZOO COUNTY PARKS PARK RULES**

1. Parks are open daily from 7:00AM to sunset. Beaches close 1/2 hour prior to park closing.
2. Possession and/or use of alcoholic beverages is prohibited within the posted limits of beach areas. No person shall sell alcoholic beverages. Consumption must comply with all applicable State and local rules and regulations.
3. Fires are permitted only in grills or designated areas. Fireworks are prohibited.
4. It is unlawful to hunt, trap or kill any animal or bird, except fish on park grounds. Limited areas may be designated in which waterfowl hunting will be permitted.
5. Solicitation, peddling, advertising, or commercial business activity is not allowed without prior approval.
6. It is unlawful to litter or dump in any park area.
7. Pets must be on a leash, no more than 6 feet long and owners must clean up after their pets.
8. All hiking trails are designated for pedestrians only. Horses are not permitted.
9. Swim only in designated beach areas during posted hours. No lifeguard on duty. Swim at your own risk.
10. Camping only in designated camping areas.
11. Persons displaying permit have priority usage of shelters.
12. It is unlawful to destroy park property.
13. Vehicles are not to be driven at more that 25 M.P.H. and on existing roads. Park only in designated areas.
14. Removing or damaging any natural material, whether alive or dead, from park property is prohibited.
15. Watercraft may only be launched from designated boat launch areas.
16. No person shall engage in any violent, abusive, boisterous, loud, illegal, obscene, or similar disorderly conduct which unreasonably interferes with another person's use or enjoyment of facility. Loudspeakers, public address systems, and sound amplifying equipment may only be used with written permit.
17. No person shall operate a ATV, ORV, snowmobile, mini-bike, go-cart, golf cart or similar motorized device.
18. No person shall fly or use radio controlled airplanes, rockets, boats, or like powered models except at designated areas.
19. No person shall post, paste, fasten, or affix any notice or sign within a facility except for temporary directional signs for picnics or special events. Temporary signs must be removed at end of event.

Choosing to violate any of Kalamazoo County Parks or Campground rules may result in eviction and/or prosecution.
